11. Should you return the product prior to the 30 day returns period you will not be eligible for the promotion.

12. In the event that a winner or substitute winner is unreachable, ineligible, the winner or substitute winner shall forfeit their Prize and it will be awarded to a substitute winner, which shall be the next Entry selected at random.
